## Scope of the financial statements

UnitedPeople at this time, has no operational bank account with any banking institution. It has not operated in the collection of any financial funding. It had not been given any financial donation in the last year. When offered them, UnitedPeople has politely declined the acceptance of them from private individuals.

UnitedPeople does not operate a youth wing at present and has not plans for the future to start one.

#### Statement of Appropriate Officer's Responsibilities

### Income and Expenditure Account and Retained Revenue Reserves

UnitedPeople has not applied nor gained any state funding at any stage.

The party does not operate a membership fee system it does not have a subscription system in place and like the membership fees, it has no plans to impose fees or subscription upon anyone.

UnitedPeople has not to date, accepted any financial donations from any person, institution, group or other pre-existing possible formation.

UnitedPeople is a voluntary party and as such there has been no staff costs to account for.

Hands-on administration of the party, presently what little there is while existing in a Covid-19 accelerated infection period, has been minimum to say the least. No physical interactions have taken place and due to distance travel restrictions at times within the last year accounting period, there has been no meetings held of any physical description or otherwise.

Any administration, what little there has been, has been managed by Jeff Rudd and Aindrui Orkney, UnitedPeople data officer.

As UnitedPeople has neither hired, leased or purchased any property, there are no costs for UnitedPeople to be applied in relation to premise costs.

As there has been no attempts to seek any fundraising, there subsequently has been no fundraising expenses incurred by any member of UnitedPeople.

As UnitedPeople does not operate with any external institution regarding (non-existing) finances, the party does not currently face any financing charges.

UnitedPeople has not run any of its current members in any local or national elections. Subsequently, there has been no campaign or election costs incurred.

 It should be noted that one now ex-member of UnitedPeople, decided on his own volition, to run for election. He funded his own leaflet expenses to the tune of €357.93 (inc' tax), for which he asked for an invoice to be sent to the party leader (instead of his own email address) without seeking further prior permission to do or even the permitted use of the party leaders name. That person is subsequently, now an ex-member of UnitedPeople.

#### Fixed assets

UnitedPeople at this time owns no fixed assets. It has no properties or physical items of value attributed to its ownership name.

The party does not have any investments of any description presently nor it did ever have since officially the registering of the party with the political party Dail registration office.

UnitedPeople owns no stock of any description, of any kind.

The UnitedPeople political party has no formal debtors of any kind at this present time.

#### **Current liabilities**

UnitedPeople is in the fortunate position that it has no creditors and or accruals of any description.

The party has not previously not presently have any loans attached to its existence

#### Statement of Cash Flows for the year ended 31 December 2020

- Due to complete inactivity in these areas there is no financial interest to report for the period 2019 to 2020. As UnitedPeople to date, has no operating bank account in existence, from such there is subsequently no cash flows, interest gained, borrowing to be paid off (nor laid out to others) and no increase or decrease in the any finance wealth of the party.
- The party does not charge anyone at any time, in order to be able join the party.
   Subsequently, there are no financial records to amass or report on. There are no other forms of membership.
- The party has not applied for state funding. The taxpayers of Ireland are already burdened
  with too much perked parties, their elected at local and national level, etc. So We make a
  deliberate choice not take unfair advantage of taxpayers who are given no ability to give or
  deny permission, regarding their money further going towards parties they might or might not
  actually like.
- UnitedPeople has not sought out donations at any time nor sought out donation in kind, at any time. There has been no fundraising either. Subsequently, there is nothing to report on these matters.
- No finances have been transferred to or from anyone within UnitedPeople or between any member of UnitedPeople and a member of the general public.
- Regarding miscellaneous income comprises, there has been no Investment incomes, no rental incomings, no service incomings or other forms of standard incomes of any description.
- UnitedPeople has no paid staff operating within it. Anyone willing to assist the party does not then gain any further benefit in kind either. Subsequently there are no PRSI contributions to be paid nor pension payments to be made or accounted for. If there is any training – none for the period of 2019 to 2020 - this is also done on a non-paid voluntary basis only.
- Regarding communications, they are done by individual members of their own accord right
  around the country. The costs of such communications are voluntary met by same people
  though their own personal mobiles charges. They do this in order not to be a further burden
  upon any island taxpayer or state department. Usage of personal phones, laptop or

computers (as well as costs of power needed to use them) are met by individuals good enough to give voluntary support.

- Campaign costs include that includes election expenses, have not been accrued for the period 2019 to 2020.
- UnitedPeople has no ownership of any buildings, nor does it have any leasing of any buildings
  dedicated to usage for the party. The party is technically Dail registered via a private address.
- UnitedPeople owns no tangible other, saleable assets on any description beyond a few banners, posters or leaflets at one time or other.
- UnitedPeople posses no stock of any description or value. None has been give away by it not has been present to it at any stage.
- There has been no investments name by the party in any official capacity nor has there been any made by any persons connected to it, for the benefit of the party.
- UnitedPeople is in the fortunate position that it owes no one any money in the period 2019 to 2020. For the foreseeable future, we do not see this present condition changing. There are not creditors connected to UnitedPeople of any kind.
